2018 Mosquito Repellant Permission

Children will apply mosquito repellant to themselves under the direct supervision of camp staff before outdoor activities. Repellant should not be applied to broken skin or if a skin reaction has been observed. Any skin reaction observed by day camp staff will be reported promptly to a parent/guardian. It is the parent's responsibility to provide repellant with the specific amount of DEET they wish their child to have. Every repellant should have their child's first and last name clearly labeled on the bottle. The Eaton's Explorers Summer Camp will be using REPEL Natural Repellant DEET-free or OFF! Repellant 15% DEET. It is recommended that you use DEET to protect against West Nile Virus.
